



**FITTING INSTRUCTIONS FOR R&G LICENCE PLATE HANGER
HYOSUNG 125R/250R 09' - (part code LP0085BK)
Please read all instructions before commencing fitting**

- NOTE YOU WILL NEED TO GLUE THE LIGHT SHROUD TO THE LED LICENCE PLATE LIGHT BEFORE FITTING USING SUPER GLUE.
- Remove the rear seat.
- Disconnect wiring to original number plate unit and indicators.
- Undo the two bolts holding the original number plate unit to the sub frame.
- Remove OEM number plate unit.
- Remove the OEM indicators and fit to the R&G license plate holder.
- Assemble new R&G license plate light to new license plate holder.
- Fit license plate holder to the bike using the two OEM bolts that you removed earlier.
- Feed all wires through hole and reconnect wiring.
- Refit rear seat
- Check operation of all lights before use
- **IMPORTANT: IF FITTING A FULL-SIZE LICENCE PLATE AND PLACING IT FAR DOWN ON THE LICENCE PLATE HANGER, THERE IS A SMALL CHANCE OF THE LICENCE PLATE HITTING THE BACK WHEEL UNDER HEAVY LOAD AND OVER LARGE BUMPS IN THE ROAD. IT IS YOUR RESPONSIBILITY TO CHECK FOR THIS POSSIBILITY AND TAKE AVOIDING ACTION. FAILURE TO CHECK THIS COULD RESULT IN SERIOUS INJURY.**

Goods must be in re-sellable condition, in the opinion of R&G Racing

All returns are subject to a 25% restocking and handling fee (25% of the gross value exc. P&P – at the prevailing price at time of purchase)

The customer must pay any and all carriage charges

No returns of discontinued products, unless within 14 days of purchase
